DEDICATION Where us, the lands described, platted and referred to in the attached plat are owned by the undersigned, Leslie Coombs, of Bartlesville, Orlahoma, and George F. Boswell, of Coffeville, Kansas, excepting the cil, gas and other mineral deposits in and under saidland, and subject to anoil and gas mining lease held by The Decorate Gas & Ou Company a company tion, and Delokee Gas to Oil Company, a corporation; and Whereas. It is desired by the parties executing this instrument that said lands be opened for townsite purposes, but inconnection therewith it is cosential that the rights of the owner of the oil, gas and mineral deposits, and his lessees, be fully protected; Now Therefore, The undersigned owners hereby dedicate the streets and alleys shown and platted on the attached plat for the use of the public forever, expressly subject, however, to the following conditions, limitations and reservations; (1) The owner of the oil, gas and other mineral deposits in and under said lands and his assignees, hereby and lessees shall at all times have the privilege

of laying, maintaining and removing pipe lines over said streets and alleys for the transportation of gas, water and oil in connection with the operation of wells for oil and gas located upon the lands described in this plat.
