KNO" ALL "EN BY THESE PRESENTS: That,

"HEREAS, the real property hereinafter described has heretofore been surveyed, and platted as a residential subdivision under the
name of HUTCHINSON SUBDIVISION OF "ACHINGTON COUNTY, OFLAHONA, and as
such has been subdivided into lots, blocks, streets and easements as
shown by the plat on file in the office of the County Clerk of Washington
County, Oklahoma, said land being described as follows:

THE "EST WALF OF THE CORTIEAST WARTER OF THE SOUTHEAST QUALTER OF THE SOUTHEAST WARTER OF SUCTION FOUR (4), TO USHIP TUENTY-SIX (26) NORTH, RANGE THIRTMEN (13) EAST.

NO", THEREFO E, "illiam H. Phillips, Grace H. Phillips and Robert V. Hutchinson, owners of the above described land, in order to assure the proper use of said real property, do hereby impress upon and attach to said lands the following restrictions, conditions and covenants:

- (1) All the lots except Lot number Thirteen (13) in this subdivision shall, for a period of twenty-five years from the First day of May, 1950, be used exclusively for residential purposes.
- (2) No residence built upon any lot in this subdivision shall contain less than 300 square feet of floor space, exclusive of porches, terraces, or attached garages. Construction shall be of masonry, stucco, or standard frame construction with sood siding, or material equal in quality and appearance.
- (3) No building shall be moved from another location onto any lot in this subdivision.
- (4) Fo livestock shall be permitted to be kept on any lot in this subdivision.
- (5) No billboards or advertising signs shall be erected or maintained nor shall any building or structure be used for advertising purposes on any lot in this subdivision.
- (6) All of the above restrictions shall be binding upon the purchaser of any lot described in said plat, and upon his or her respective heirs, successors and assigns and shall continue for a period of twenty-five years from Way 1, 1950, at which time said restrictions shall be automatically extended for successive periods of ten years, unless by vote of the majority of the then owners of the lots it is agreed to change said restrictions in thole or in part.
- (7) Invalidation of any one of these covenants by a judgment or Court Order shall in nowise affect any of the other provisions which shall remain in full force and effect.

THRITER DECLARE THAT these restrictions are covenants and shall be annexed to run with the land, and either the grantors herein or any owner of real estate in Hutchinson Subdivision, "Lashington County, Oklahoma, snall have the right to enforce said restrictions in any court of competent jurisdiction either by suit or injunction, to prevent the violation of such restrictions, or to recover damages for a violation of such restriction.
