RESTRICTIONS, RESERVATIONS AND COVENANTS ON AND PERTAINING TO LIMESTONE HEIGHTS, A SUBDIVISION OF "ASHINGTON COUNTY, OKLAHOMA

KNOW ALL MEN BY THESE PRESENTS:

THAT, "HEREAS, the undersigned, FRED L. CHANEY, NELLIE M. CHANEY, G. E. CHANEY, VERIAN J. CHANEY, GILBERT Z. BROCK, GEORGIA K. BROCK and M. W. MAPLE, as the owners, have caused to be surveyed and platted as a subdivision of "ashington County, Oklahoma, under the name of Limestone Heights, the following described real estate in said county, to-wit:

The South Half of the Northeast Quarter of the Southeast Quarter of Section Twenty (20), Township Twenty-Six (26) North, Range Thirteen (13) East;

and have caused the same to be subdivided into lots, blocks, streets, avenues, drives and public ways and have dedicated the same to the public use, subject to certain restrictions, reservations and covenants referred to in said dedication:

NOW, THEREFORE, said owners declare that the land shown on said plat above referred to is held and shall be conveyed subject to the following restrictions, reservations and covenants, to-wit:

1. Use:

All lots in this addition shall, for a period of twenty years from the first day of June, 1951, be used exclusively for residential purposes, except Lots One (1) and Sixteen (16) in Block Four (4) and Lot One (1) in Block Five (5), which may be used for business purposes. One family residences only may be erected, and only one such residence upon each lot.

2. Floor Space and Construction:

Each residence shall contain at least 800 feet of floor space, exclusive of porches, terraces or attached garages; said residence shall be constructed of masonry, stucco, or standard frame construction with wood siding, or materials equal in quality and appearance. Minimum plumbing requirement for each residence shall consist of standard five-piece sanitary equipment, connected with septic tank, which septic tank or sub-surface sewage disposal system shall be constructed in substantial compliance with the specifications of the Board of Environmental Sanitation of the Oklahoma State Sanitation Department. No building shall be moved from another location to any lot in this addition.

3. Frontage and Set Lack:

Each residence chall broat and present a good frontage on the street which the lot broats, and any residence that it be erected upon a corner lot in this addition shall have a presentable frontage on both streets. No residence or outbuilding or part this polynomial polynomial be erected closer to the struct or structs than the building limit limit (50 feet) indicated on the official plat of this addition.

porches, chimneys, or bay windows shall be placed clowr to any side lot than five fact.

5. Assements was ved in Lots:

The undersigned reserve the right to locate, construct, erect and raintain, or cause to be located, constructed, erected and maintained in and on the areas indicated on the plat as "Lase ents", select and other ripe lines, conduits, poles and lines and lay other method of conducting or performing any public or quasi-public utility function above or beneath the surface of the ground, with the right of access at any time to the same for the purpose of repair and maintainance.

6. Billboards, Signs and siscellaneous Structures:

No billboards or acvertising bight shall be eracted or maintained upon any lots in this addition nor shall any building of structures be erected thereon for advertising purposes. To permanent provision shall be made for the housing of poultry, cows, horses of other livestock on any lot, nor shall any livestock be kept and maintained on said promises.

7. Duration:

upon the undersigned and upon their heirs, successors and assigns for a period of themsy years from date of dedication and shall automatically be extended thereafter for successive periods of tem years; provided, notever, that the owners of the fee simple title to the lots having note than fifty pur cent of the front feet of the lots shown on this plat may release all of the lots hereby restricted from any one or more of said restrictions, and may release any lot from any restriction created by deed from any one of the undersigned, at the end of the first twenty years period or of any successive ten years period

thereafter, by executing and acknowledging an appropriate agreement or agreements in writing for such purpose and filling the same for record in the office of the County Clerk of ashington County at least three years prior to the expiration of the first twenty years period, or of any ten years period thereafter.

8. Right to inforce:

The restrictions herein set forth shall run with the land and bind the present o ners, their heirs, successors and assigns. And all parties claiming by, through or under them shall be taken to hold, agree and covenant with the owners of said lots, their heirs, successors and assigns, and with each of them, to conform to and observe said restrictions as to the use of said lots and the construction of improvements thereon, but no restriction herein set forth shall be personally binding upon any corporation, person or persons, except in respect to breaches committed during its, his or their seisin of or title to said land, and the owner or owners of any of said land shall have the right to sue for and obtain an injunction prohibitive or mandatory, to prevent the breach of or to enforce the observance of the restrictions above set forth in addition to ordinary legal actions for damages, and failure of the undersigned or the owner or owners of any other lot or lots shown on this plat to enforce any of the restrictions herein set forth at the time of its violation shall in no event be deemed to be a waiver of a right to do so thereafter.
