OWNER'S CERTIFICATE OF RESTRICTIONS DEC 29 1977

KNOW ALL MEN BY THESE PRESENTS:

That Adams Realty Company, a Delaware corporation, does here-by certify that it is the owner of and the only corporation or corporations, person or persons, having any right, title or interest in and to the land included in Madison Heights Tenth Addition now platted into lots, streets and easements as shown on the Plat Envelope 413 of the records of the County Clerk of Washington, County, Oklahoma.

For the purpose of providing an orderly development of all the lots included in said addition, and for the further purpose of providing adequate restrictive covenants for the benefit of the owner and its successors in title to the aforementioned lots, Adams Realty Company, does hereby impose the following restrictions and reservations on all of said Madison Tenth Addition to which it shall be incumbent upon its successors in title to adhere, and any person or persons, corporation or corporations hereinafter becoming the owner or owners, either directly or through any subsequent transfer or in any manner whatsoever of any lots subject to the following restrictions and reservations, to wit:

- A building site shall be restricted to one family residences, except for those provisions hereinafter contained relating to the occupancy of said lands for family servants. Said building site or plot may be one lot, more than one lot or less than one lot but each building site or plot shall have an area of not less than 7,000 square feet and shall not be less than 70 feet in width at the front building line, except for Lots 9 and 10 in said addition.
- All lots in said addition shall be used exclusively for residential purposes, and no residence or other structure shall be used either in whole or in part as a professional office, shop, school or studio, or for the conduct of any business or trade.
- No structure shall be erected, placed or permitted to remain on any lot or building plot, as above defined, other than one single family residence and buildings appurtenant thereto such as a garage, servants quarters, children's playhouse and garden shelter.
- All residences erected in said addition shall have a minimum of 1,400 square feet of living area under one roof, exclusive of garage and outbuildings, and shall be constructed of masonry or standard frame construction with wood siding or of materials equal in quality and appearance.
- No building shall be moved from another location onto (5) any lot in the addition.
- No garage or other outbuildings erected on any tract in said addition shall be used for residential purposes other than for such use by the servants employed on said premises by the occupants thereof.

- (7) No activity shall be carried on any of the lots which shall constitute a nuisance and no fowls or other animals except household pets shall be kept on any lot in this addition.
- (8) No residence of any building appurtenant thereto shall be erected on any lot or plat in said addition nearer the street than the building line shown on the recorded plat of this addition. No building shall be constructed nearer to the side line of any building plot than is permitted by the Zoning Ordinances adopted by the City of Bartlesville, Oklahoma.
- Any residence erected on any lot that abuts more than one street shall have a presentable frontage on each abutting street.
- (10) No fence whether ornamental or otherwise shall be erected nearer to the front property line than the front building line.
- (11) No billboard or advertising sign shall be erected or maintained except for the sole purpose of advertising the sale of the building plot upon which the sign may be placed, and such sign shall not exceed eight (8) square feet in area.
- (12) If the owner or tenant of any lot or lots in Madison Heights Tenth Addition should violate any of the restrictive convenants contained herein, and thereafter refuse to correct the convenants contained herein, and thereafter refuse to correct the same and to abide by said restrictions, the owner of any lot or building site in the Addition may institute legal proceedings to enjoin, abate and/or correct such violation or violations, and the owner of the lot or building site permitting the violation of such restrictions shall pay all attorney fees, court costs and other expenses incurred by the person instituting such legal proceedings, said attorney fees to be fixed by the court. The amount of said attorney fees, court costs and other expenses allowed and assessed by the court shall become a lien upon the land as of the date legal proceedings were originally instituted, and said lien shall be subject to foreclosure in such action, so brought to enforce such restrictions.
- (13)Easements for public utility installations and maintenance are hereby reserved where shown on the recorded Plat of this addition. Companies furnishing utilities shall have the right of ingress and egress along said easements for such installations and maintenance.

Street light poles or standards may be served by underground cable, and elsewhere throughout said addition all supply lines shall be located underground, in the easements reserved for utility installations and streets shown on the recorded Plat of said addition. Service pedestals and transformers, as sources of supply at secondary voltages, may be located in said easements.

Underground service cables to all houses which may be located on all lots in said addition may be run from the nearest service pedestal or transformer, to the point of usage determined by the location and construction of such house as may be located upon each said lot; provided, that upon the installation of such a service cable to a particular house, the supplier of electric service shall thereafter be deemed to have a definitive, permanent, effective and exclusive right of way easement on said lot, covering a five-foot strip extending 2.5 feet on each side of such service cable, extending from the service pedestal or transformer to the service entrance on said house.

The supplier of electric service, through its proper agents and employees, shall at all times have right of access to all easements shown on said Plat, or provided for herein, for the purpose of installing, maintaining, removing or replacing any portion of said underground electric facilities so installed by it.

The owner of each lot shall be responsible for the protection of the underground electric facilities located on his property and shall prevent the alteration of grade or any construction activity which may interfere with said electric facilities. The supplier of electric service will be responsible for ordinary maintenance of underground electric facilities, but the owner of each lot will pay for damage or relocation of such facilities caused or necessitated by acts of the owner or his agents or contractors.

The foregoing covenants concerning underground electric facilities shall be enforceable by the supplier of electric service, and the owner of each lot agrees to be bound hereby.

- (14) These restrictive covenants shall run with the land and shall be binding on all parties and all persons for a period of thirty (30) years from the date hereof, at which time said covenants shall be automatically extended for successive periods of ten (10) years, unless by vote of the majority of the then owners of the said lots or building sites it is agreed to change said covenants in whole or in part.
- (15) Invalidation of any of these covenants by judgement or order of a court shall in no wise affect any of the other provisions herein, and such other provisions shall remain in full force and effect.
