ABSTRACT OF CITY ORDINANCE. Number 231.

AN ORDINANCE ADDING TO THE CITY OF BARTLESVILLE, OKLAHOMA, CERTAIN TERRITORY ADJACENT TO THE CITY LIMITS OF SAID CITY.

BE IT ORDAINED by the Mayor and Councilmen of the City of Bartlesville, Oklahoma.

SECTION ONE.

That the following described tract of land lying and being adjacent to the said City of Bartlesville and particularly described as follows, to-wit: The NORTH WEST Quarter of the NORTHEASI Quarter of the NORTHEAST Quarter, and the NORTH ONE HUNDRED feet of the SOUTHWEST Quarter of the NORTHEAST Quarter of the NORTHEAST Quarter of SECTION THIRTEEN, TOWNSHIP TWENTY SIX North, RANGE TWELVE East, be and the same hereby is brought into and made a part of the said City of Bartlesville; and the corporate limits of said City of Bartlesville shall be and the same hereby are extended over and around said tract above described so as to include the whole thereof in said City, which said tract shall be known and designated as the PEMBERTON HEIGHTS ADDITION to the City of Bartlesville, Oklahoma.

SECTION TWO.

That all of the streets, alleys and public places as laid out in said addition according to the plat thereof herewith filed, and as dedicated on said plat to the use and benefit of the City of Bartlesville, Oklahoma, forever, which said plat has been duly recorded according to law, be and the same are hereby accepted and said plat approved and confirmed, and the said streets, alleys and other public places, as aforesaid, are made the streets, alleys and public places of the City of Bartlesville, Oklahoma.

SECTION THREE.

That the inhabitants of said tract of land shall have an enjoy all of the rights, privileges, protection and immunities that other citizens of said City have and enjoy, and shall be subject to all the duties and requirements of said City and to all of its laws and ordinances.

SECTION FOUR.

That the Mayor and Council of said City, shall, as soon as practicable cause the streets of said addition to be properly lighted with electric light arc lights, and cause the water works company to extend its system of mains and install hydrants sufficient for adequate fire protection.

That the City will construct on the streets and alleys thereof cross-walks to connect with the sidewalks where ever the same extend the entire length of the block.

SECTION FIVE.

That no right of way shall ever be given to any street railway Company to construct or operate a street railway line on Cherokee Avenue in said Addition.

SECTION SIX.

This Ordinance shall take effect and be in force from and after, its passage, approval and publication according to law.
