

OWNER'S CERTIFICATE AND RESTRICTIONS OF
PRAIRIE RIDGE
BARTLESVILLE, WASHINGTON COUNTY, OKLAHOMA

KNOW ALL MEN BY THESE PRESENTS:

That Coast Construction Co., an Oklahoma Corporation, does hereby certify that it is the Owner of the following described real estate located in Washington County, Oklahoma, to wit:

A part of the W/2, SE/4 of Section 3, Township 26 North, Range 13 East, City of Bartlesville, Washington County, Oklahoma

(SEE ATTACHED FOR COMPLETE LEGAL)

which real estate has been surveyed and platted in lots and blocks under the name of "Prairie Ridge" as reflected by that certain Deed of Dedication and Plat recorded in the office of the County Clerk of Washington County, Oklahoma in Plat Envelope No.

592.

For the purpose of providing an orderly development of all the lots and blocks included in the above described plat and for the purpose of providing adequate restrictive covenants for the benefit of the owners and their successors in title to the aforesaid lots, the owners do hereby impose the following restrictions and reservations on all of the said Prairie Ridge (the "Addition"), to which it shall be incumbent upon its successors in title to adhere and any person or persons, corporation or corporations, hereafter becoming the owner or owners, either directly or through any subsequent transfer or in any manner whatsoever, of any lot or lots included in the Addition, shall take, hold and convey the same subject to the following restrictions and reservations, to-wit:

1. All lots in the Addition shall be used exclusively for residential purposes. No residence or other structure shall be used either in whole or in part as a professional office, shop, school, or studio or for the conduct of any business or trade.
2. No structure shall be erected, placed or permitted to remain on any lot other than one (1) single family residence and building appurtenant thereto, such as a garage, servant's quarters, children's playhouse, swimming pool and bath house, and garden shelter. No house, garage or any other building shall be moved into the addition.

3. No residence shall be constructed containing less than 2,400 square feet of usage space, exclusive of breeze-ways, porches, attached garages, walks, driveways, swimming pools and bath houses. Each residence shall be constructed in main of brick, brick veneer, stone, stone veneer or wood siding (Concrete block not acceptable).
4. In order to assure that structures constructed within the Addition shall conform and harmonize in design with respect to topography and finished ground elevation, prior to the expiration of ten (10) years from the date hereof, no building shall be erected, placed or materially altered until the building plans, specifications, and plot plan showing the location of the buildings shall have been approved in writing by Coast Construction Co. which approval shall be indicated by a certificate signed and acknowledged by an Officer of said Company.
5. No building shall be erected on any lot nearer to the front lot line, side street line, interior lot lines or rear lot line than the minimum building set back as set forth in the zoning regulations for the Bartlesville Metropolitan Area Planning Commission, adopted by the Board of Commissioners of the City of Bartlesville, August 1, 1966 and amendments thereto.
6. Any lot that abuts more than one street shall be deemed to front on either street abutted, and any residence erected upon such a lot shall have a presentable frontage on each side abutting street.
7. No noxious or offensive activity shall be carried on upon any lot, nor shall anything be done thereon which may become an annoyance or a nuisance to the neighborhood, and no building shall be erected upon any of the lots in this subdivision which is designated or utilized to house poultry, cows, horses, rabbits, or other livestock, nor shall any such poultry, cows, horses, pigs, rabbits or other livestock be kept or maintained upon the premises.
8. No basement, tent, shack, trailer, garage, barn or other structure of a temporary character shall be erected for use, utilized or occupied as a residence.
9. No billboards or advertising signs or structures shall be erected or maintained upon any lot in the addition, except only for a "for rent" or "for sale" sign, of which one sign not exceeding 24" X 36" in size.
10. Roof materials shall be wood, slate, tile or heavy composition. Composition roof materials shall be asphalt or fiberglass material with a weight of #300 or more per square, and shall be simulated shake in appearance. (standard composition shingles not acceptable).
11. No fence, whether ornamental or otherwise, shall be erected on any lot nearer to the front property line than the front building lines.

12. The owner reserves the right to locate, construct, erect and maintain or cause to be located, constructed, erected and maintained in and on the areas indicated on the plat as "easement", sewer and other utility pipelines, conduits, poles, wires and other similar instrumentalities capable of performing public or quasi-public utility functions, both above or beneath the surface of the ground, with the right of access at any time to the same for purpose of installation, repair, maintenance and removal.
13. Areas designated on the plat of the Addition as "Restrictive Drainage Easement" (RD/E) are hereby established by grant of the owner as a perpetual restrictive easement for the purpose of permitting the flow, conveyance and discharge of storm water runoff from the various lots within the Addition and from properties outside the Addition. Drainage facilities constructed in said Restrictive Drainage Easement shall be in accordance with standards prescribed by the City of Bartlesville and plans and specifications approved by the City Engineer of the City of Bartlesville. The Restrictive Drainage Easement shall be maintained by the lot owner upon which said easements are located at his cost in accordance with standards prescribed by the City of Bartlesville. In the event a lot owner shall fail to adequately and properly maintain said easement, the City of Bartlesville, may enter upon said easement and perform said maintenance, and the cost of performing said maintenance shall be paid by said lot owner. In the event said lot owner fails to pay the cost of maintenance within thirty (30) days after completion of same, said cost shall be a lien against the defaulting owner's lot(s) which may be foreclosed by the City of Bartlesville.

No fence, wall, plating, building or other obstruction shall be placed or maintained in said Restrictive Drainage Easement without approval of the City Engineer of the City of Bartlesville, and there shall be no alterations of the grades or contours in said easements without the approval of said City Engineer.

Said easements or any part thereof may be terminated, released and canceled upon resolution duly adopted by the Bartlesville Board of Commissioners.

14. Owner desires that the supply of electricity throughout said Addition be provided, to the fullest extent deemed practicable by facilities located underground rather than overhead, and for the purpose of facilitating such installation, Owner agrees to include the following provisions in the Deed of Dedication creating said plat and subdivision, to wit:
- (a) Street light poles or standards may be served by underground cable and elsewhere throughout said Addition all supply lines shall be located underground, in the easement-way reserved for general utility services and street, shown on the attached plat. Service pedestals and transformers, as sources of supply at secondary voltages, may also be located in said easement-ways.

- (b) Underground service cables to all houses which may be located on all lots in said Addition may be run from the nearest service pedestal or transformer to the point of usage determined by the location and construction of such house as may be located upon each said lot; provided that upon the installation of such a service cable to a particular house, the supplier of electric service shall thereafter be deemed to have a definitive, permanent, effect and exclusive right-of-way easement on said lot, covering a five-foot strip extending 2.5 feet on each side of such service cable, extending from the service pedestal of transformer to the service entrance on said house.
 - (c) The supplier of electric service, through its proper agents and employees shall at all time have right of access to all such easement-ways shown on said plat, or provided for in this Deed of Dedication for the purpose of installing, maintaining, removing or replacing any portion of said underground electric facilities so installed by it.
 - (d) The owner of each lot shall be responsible for the protection of the underground electric facilities located on his property and shall prevent the alteration of grade or any construction activity which may interfere with said electric facilities. The Company will be responsible for any ordinary maintenance of underground electric facilities, but the owner will pay for damage or relocation of such facilities caused or necessitated by acts of the owner or his agents or contractors.
 - (e) The foregoing covenants concerning underground electric facilities shall be enforceable by the supplier of electric service and the owner of each lot agrees to be bound hereby.
15. The initial purchaser of each lot contained in the Addition shall be responsible for and shall bear the cost and expense of sidewalks as may be required by the city of Bartlesville, Oklahoma.
16. These covenants and restrictions shall run with the land, and shall be binding upon all persons owning lots in the Addition for a period of twenty (20) years from the date these covenants are recorded, after which time said covenants shall be automatically extended for successive periods of ten (10) years each. The restrictions contained herein (with the exception of paragraphs 12, 13, and 14) may be modified, amended and/or waived by an instrument which is signed by a majority of the then owners of the lots agreeing to such modification, amendment and/or waiver.

Enforcement shall be by proceedings at law or in equity against any person or persons violating or attempting to violate any covenant either to restrain violation or to recover damages.

Invalidation of any one of these covenants by judgment or court order shall in no wise affect any of the other provisions which shall remain in full force and effect.

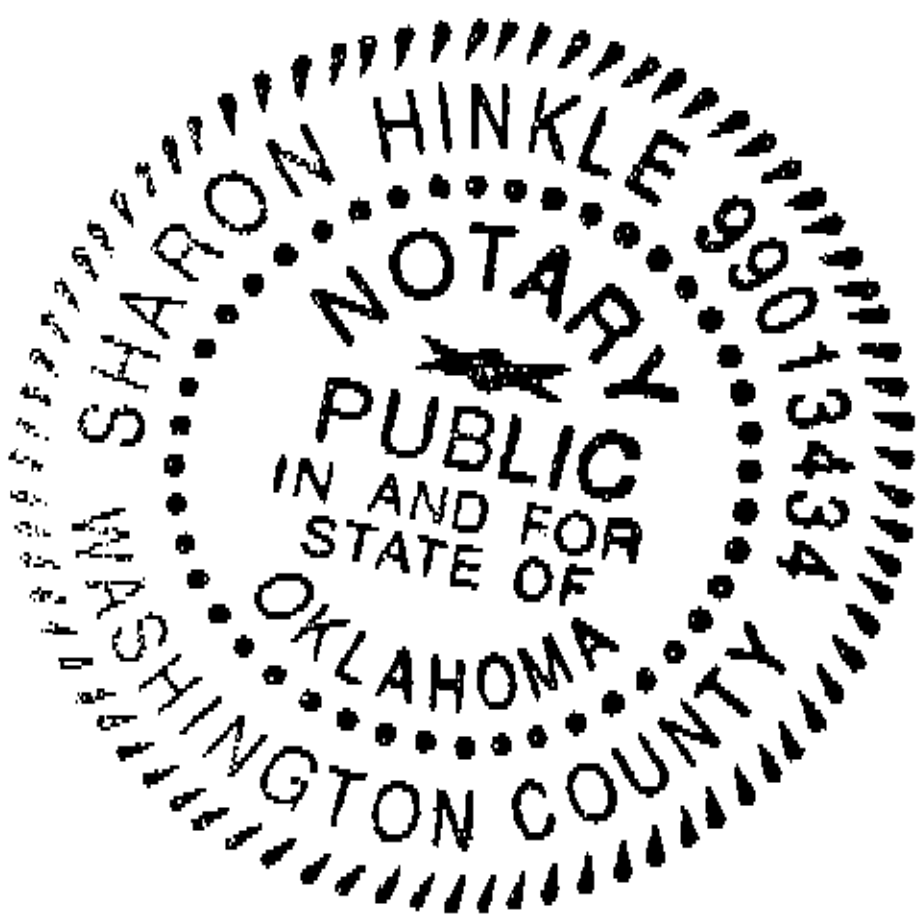

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on March 1, 2005, Coast Construction Co., an Oklahoma corporation, executed and recorded of record in Book 1036 Page 2 in the office of the County Clerk of Washington County, Oklahoma, the Owner's Certificate and Restrictions of Prairie Ridge, Bartlesville, Washington County, Oklahoma (the "Restrictions"); and

WHEREAS, the Restrictions provide that the same may be amended by instrument signed by a majority of the then owners of lots agreeing to such modification or amendment; and

WHEREAS, Coast Construction Co., an Oklahoma corporation, is the owner of 86 of the 91 residential lots of Prairie Ridge, Bartlesville, Washington County, Oklahoma ("Prairie Ridge") and a majority owner of lots in Prairie Ridge, desires to amend the Restrictions as follows:

1. The Restrictions are hereby amended by striking paragraph 11 and in its place, substituting the following:

11. No fence, whether ornamental or otherwise, shall be erected on any lot nearer to the front property line than the front building setback line and with regard to any and all corner lots, no fence shall be erected nearer to the side property line than the side building setback line. Standard chain link fences are strictly prohibited; however, fencing composed of chain link material that is painted and framed in wood is acceptable. Such chain link fencing must not exceed four feet in height. Other fencing composed of masonry or wood must not exceed six feet in height.

2. Except as amended and modified hereby, the Restrictions remain in full force and effect.

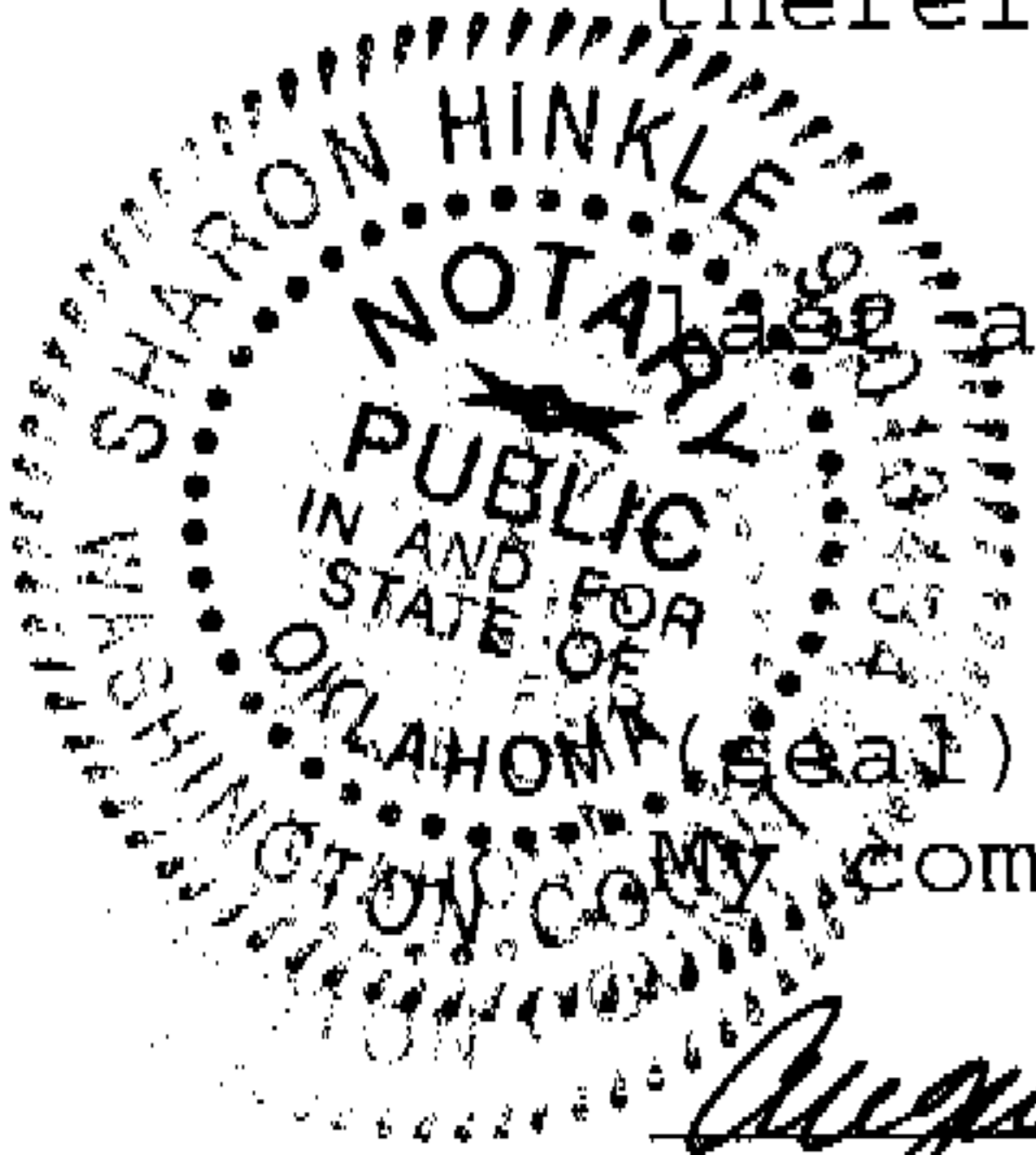

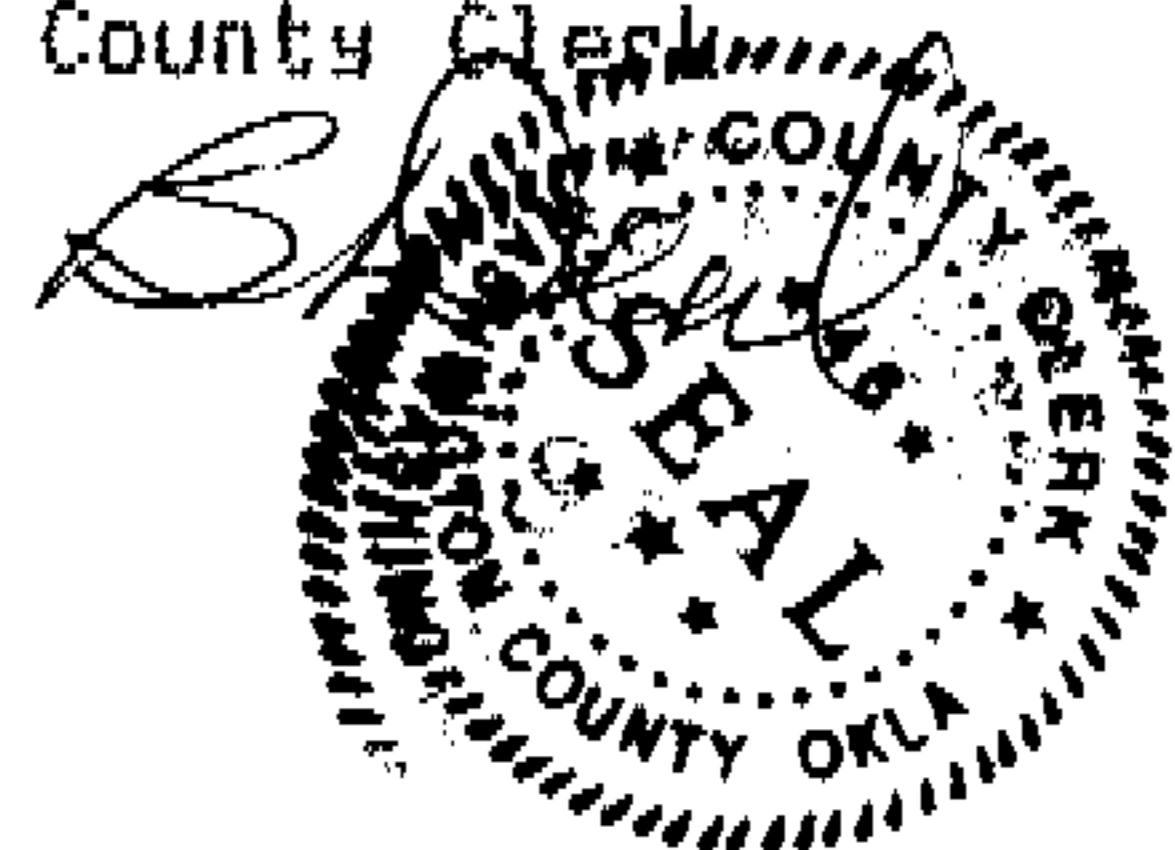

This Amendment to the restrictive covenants entitled "Owners Certificate and Restrictions" (the Covenants) is made effective as of the date of filing by the owners of Lots within Prairie Ridge to the City of Bartlesville, Washington County, State of Oklahoma (the Addition), according to the recorded plat, as such owner votes are recorded in the corporate records of the Association, and as evidenced by the signature pages attached hereto.

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the Addition is a platted addition to Washington County, such Deed of Dedication and Plat being recorded within the Washington County Clerk's Office at Plat Envelope Number 592 and Book 1036, Page 1 and being particularly described as set out within Exhibit "1" attached to this Amendment.

WHEREAS, the Covenants to the Addition were recorded within the Washington County Clerk's Office at Book 1036, Page 2.

WHEREAS, the owners of parcels within the Addition desire to add a new section to the Covenants for the purpose of creating, establishing, and organizing a neighborhood association for the Addition that requires the mandatory participation of 1) those parcel owners presently declaring their lot(s) to the newly created neighborhood association, and 2) all successors in interest of the parcels owners at the time this amendment is recorded. Unless a record owner declares their present intent to belong to the association, participation in the owners association shall not be mandatory for persons who are record owners of parcels within the Addition at the time the Amendment is filed of record, but such participation shall be mandatory for all successors-in-interest of the record owners.

WHEREAS pursuant to notice and meeting, a sufficient percentage of record owners of parcels within the Addition voted to amend the Covenants and to approve the Amendment, the ballots of such owners voting to approve being attached hereto.

WHEREAS copies of the signature pages and/or proxies of such owners are contained in the corporate records of the Secretary of the Association, with copies of the same retained in the files of Matthew L. Winton, Esq. of the firm VAUGHN, WINTON & CLARK^{PLLC};

NOW THEREFORE, the Covenants to the Addition are hereby amended to add the following language.

SECTION 17 – OWNERS ASSOCIATION

17.1 DEFINITIONS. The terms used in the Governing Documents shall be given their natural, commonly accepted definitions unless otherwise specified. Capitalized terms shall be defined as set forth below. If not defined herein, capitalized terms shall be defined as set forth in the Amendment, as applicable.

1. "**Association**": The community association created by this amendment, which may be incorporated at any time as an Oklahoma nonprofit corporation, its successors or assigns.
2. "**Base Assessment**": Assessments levied on all Lots subject to assessment to fund Common Expenses for the general benefit of the Addition, as determined in accordance with Section 17.3.
3. "**Board of Directors**" or "**Board**": The body responsible for administration of the Association, selected as provided in the By-Laws. Unless otherwise specifically noted, any reference to the Board in the Governing Documents means the Association board.
4. "**Common Area**": All real and personal property, including easements, which the Association owns, leases or otherwise holds possessory or use rights in for the common use and enjoyment of the Owners.
5. "**Common Expenses**": The actual and estimated expenses incurred, or anticipated to be incurred, by the Association for the general benefit of all Owners, including any reasonable reserve, as the Board may find necessary and appropriate pursuant to the Governing Documents. Common Expenses shall not be limited to those expenses relative to the care of Common Area.
6. "**Prairie Ridge**" or the "**Addition**": The real property described in **Exhibit "1"** attached hereto.
7. "**Governing Documents**": A collective term referring to the Covenants, this Amendment and any applicable amendments, the By-Laws of the Association, (the "By-Laws"), the Articles of Incorporation of the Association, (the "Articles"), the rules, regulations, and resolutions as they may be amended.
8. "**Lot**": A portion of the Addition, whether improved or unimproved, which may be independently owned and is intended for development, use, and occupancy as an attached or detached residence for a single family, as such Lots are more particularly set out in the Plat. The term shall refer to the land, if any, which is part of the Lot as well as any improvements thereon.

9. "**Member**": Any Person subject to membership in the Association pursuant to Section 17.2 and responsible for the payment of assessments under Section 17.3.
10. "**Owner**": One or more Persons who hold the record title to any Lot, but excluding in all cases any party holding an interest merely as security for the performance of an obligation.
11. "**Person**": A natural person, a corporation, a partnership, a trustee, a limited liability company, or any other legal entity.
12. "**Plat**": The recorded instrument within the Washington County Clerk's Office at Plat Envelope Number 592 and Book 1036, Page 1.
13. "**Record**," "**Recording**," or "**Recorded**": To file, filing, or filed of record in the official records of the Washington County Clerk, State of Oklahoma. The date of Recording shall refer to that time at which a document, map, or plat is Recorded.
14. "**Special Assessment**": Assessments levied in accordance with Section 17.3.3.
15. "**Specific Assessment**": Assessments levied in accordance with Section 17.3.4.

17.2 THE ASSOCIATION AND ITS MEMBERS

17.2.1 Function of Association. The Association is the entity responsible for management, maintenance, operation and control of the Common Area and generally to serve the health, safety, and welfare of the Owners and Members. The Association shall perform its functions in accordance with the Addition Governing Documents and the laws of the State of Oklahoma.

17.2.2 Membership; Voting. The Owner of each Lot shall be a Member of the Association either because such Owner 1) presently declared themselves to be a Member of the Association at the time of such Owner's vote to approve this Amendment, or 2) such Owner is a successor in title to an Owner at the time of this Amendment's adoption. Membership is appurtenant to and cannot be separated from ownership of a Lot. There is only one membership per Lot. There is only one class of membership. If a Lot is owned by more than one Person, all co-Owners shall share the privileges of such membership, subject to reasonable Board regulation and any restrictions on voting set forth in the Governing Documents, and all such co-Owners shall be jointly and severally obligated to perform the responsibilities of Owners; however, only one vote per Lot shall ever be cast in any voting matter, to be determined as co-Owners decide. The membership rights of an Owner which is not a natural person may be exercised by any officer, director, partner or trustee, or by the individual designated from time to time by the Owner in writing and delivered to the Secretary of the Association.

17.3 ASSOCIATION FINANCES

17.3.1 Budgeting and Allocating Common Expenses. Prior to or contemporaneous with the invoicing of assessments, the Board may prepare a budget of the estimated Common Expenses for the coming year, including any contributions to be made to a reserve fund pursuant to Section 17.3.2. The budget shall also reflect the sources and estimated amounts of funds to cover such expenses, which may include any surplus to be applied from prior years, any income expected from sources other than assessments levied against the Lots, and the amount to be generated through the levy of Base Assessments and Special Assessments against the Lots, as authorized in Section 17.3.5.

The first Base Assessment approved by the record owners is **\$175.00**. Thereafter, the Association is hereby authorized to levy Base Assessments in that same amount as last assessed against all Lots subject to assessment to fund the Common Expenses.

The Board may revise the budget and seek adjustment of the Base Assessment from time to time during the year. Notwithstanding any provision to the contrary, the Board shall obtain the concurring vote of not less than sixty percent (60%) of the record owners of parcels for any change in the Base Assessment amount.

17.3.2 Budgeting for Reserves. The Board may prepare and review at least annually reserve budgets for the Common Area. The budgets shall take into account the number and nature of replaceable assets, the expected life of each asset, and the expected repair or replacement cost. The Board may include in the Common Expense budget adopted pursuant to Section 17.3.1, capital contributions to fund reserves in amounts sufficient to meet projected needs with respect both to amount and timing by annual contributions over the applicable budget period.

17.3.3 Special Assessments. In addition to other authorized assessments, the Association may levy Special Assessments to cover unbudgeted expenses or expenses in excess of the amount budgeted. Any such Special Assessment may be levied against the entire membership. Except as otherwise specifically provided in this Amendment, any Special Assessment shall require the affirmative vote or written consent of Members representing more than 50% of the total votes allocated to Lots which will be subject to such Special Assessment. Special Assessments shall be payable in such manner and at such times as determined by the Board, and may be payable in installments extending beyond the fiscal year in which the Special Assessment is approved.

17.3.4 Specific Assessments. The Association shall have the power to levy Specific Assessments against a particular Lot or Lots as follows:

(1) to cover the costs, including overhead and administrative costs, of providing services to a Lot upon request of an Owner pursuant to any menu of special services which may be offered by the Association. Specific Assessments for special services may be levied in advance of the provision of the requested service; and

(2) for fines, penalties, and costs incurred in bringing a Lot into compliance with Addition Governing Documents, or costs incurred as a consequence of the conduct of the Owner or occupants of a Lot, their agents, contractors, employees, licensees, invitees, or guests; provided, the Board shall give the Lot Owner prior written notice and an opportunity for a hearing, in accordance with Board established procedures, before levying any Specific Assessment under this subsection. A fine schedule may be adopted by the Board and any fine schedule so adopted shall be first mailed to each Owner prior to its enforcement.

17.3.5 Authority To Assess Owners; Time of Payment. The Association is hereby authorized to levy assessments as provided for in this Section and elsewhere in Addition Governing Documents against all Lots whose Owners are Members.

Unless otherwise required or provided for by the Board, Base Assessments shall be due and payable in advance on January 31st of each calendar year. Otherwise, Assessments shall be paid in such manner and on such dates as the Board may establish. The Board may require advance payment of assessments at the closing of the transfer of title to a Lot and impose special requirements for Members with a history of delinquent payment. If the Board so elects, assessments may be paid in two or more installments. If any Member is delinquent in paying any assessments or other charges levied on their Lot, the Board may require the outstanding balance on all assessments to be paid in full immediately.

17.3.6 Obligation for Assessments. Each Owner who is a Member, and each Owner of a Lot who takes title subsequent to the filing of this Amendment, is deemed to covenant and agree to pay all assessments authorized in the Governing Documents. All assessments, together with interest (computed from its due date at a rate of 10% per annum or such higher rate as the Board may establish, subject to the limitations of Oklahoma law), late charges as determined by Board resolution, costs of collection, and reasonable attorneys' fees and costs, and any other costs, fees or charges authorized herein or elsewhere in the Governing Documents shall be the personal obligation of each Owner and a lien upon each Lot until paid in full. Upon a transfer of title to a Lot, the grantee shall be jointly and severally liable for any assessments and other charges due at the time of conveyance.

Failure of the Board to fix assessment amounts or rates or to deliver or mail each Owner an assessment notice shall not be deemed a waiver, modification, or a release of any Owner from the obligation to pay assessments. In such event, each Owner shall continue to pay Base Assessments on the same basis as during the last year for which an assessment was made, if any, until a new assessment is levied, at which time the Association may retroactively assess any shortfalls in collections.

No Owner may exempt themselves from liability for assessments by non-use of Common Area, abandonment of a Lot, or any other means. The obligation to pay assessments is a separate and independent covenant on the part of each Owner. No diminution or abatement of assessments or set-off shall be claimed or allowed for any alleged failure of the Association to take some action or perform some function required of it, or for inconvenience or discomfort arising from the making of repairs or improvements, or from any other action it takes.

The Association shall, upon written request from an Owner, Mortgagee, or other Person designated by the Owner, furnish a certificate signed by an officer of the Association setting forth whether assessments for such Owner's Lot have been paid and any delinquent amount. Such certificate shall be binding upon the Association, the Board, and the Owners. The Association may require the advance payment of a reasonable processing fee for the issuance of such certificate.

17.3.7 Lien for Assessments. All assessments, fines, penalties, and other charges of the Association authorized in this Section or elsewhere in this Amendment or the Governing Documents shall constitute a lien against the Lot against which they are levied from the time such assessments or charges become delinquent until paid. The lien shall also secure payment of interest (subject to the limitations of Oklahoma law), late charges (subject to the limitations of Oklahoma law), fines, and costs of collection (including attorneys' fees and costs, lien fees and administrative costs). Such lien shall be superior to all other liens, except those deemed by Oklahoma law to be superior. The Association may enforce such lien, when any assessment or other charge is delinquent, by any means permissible under Oklahoma law, including foreclosing such lien under 60 O.S. §852. The Association may sue for unpaid assessments and other charges authorized hereunder without foreclosing or waiving the lien securing the same.

The sale or transfer of any Lot shall not affect the assessment lien or relieve such Lot from the lien for any subsequent assessments. Notwithstanding any other provision of these Covenants, no governmental authority or public utility shall be liable for assessments on any Lot dedicated to and accepted by the governmental authority or public utility ("Dedicated Property") which arose prior to its acceptance of such Lot. Dedicated Property shall include, without limitation, such areas created by or dedicated in the form of easements, including, perpetual easements, tract easements, and easements in favor of the City of Bartlesville or municipal use property.

✓ This Amendment to the restrictive covenants entitled "Owners Certificate and Restrictions" (the Covenants) is made effective as of the date of filing by the owners of Lots within Prairie Ridge to the City of Bartlesville, Washington County, State of Oklahoma (The Addition), according to the recorded plat, as such owner votes are recorded in the corporate records of the Association, and as evidenced by the signature pages attached hereto:

WHEREAS, on November 5, 2010 PRAIRIE RIDGE PROPERTY OWNERS ASSOCIATION, an Oklahoma corporation, executed and recorded of record at Book 1094, Page 48 in the office of the County Clerk of Washington County, Oklahoma, the Amendment to the Owner's Certificate and Restrictions filed at Book 1036, Page 2 for the Prairie Ridge Residential Addition located within the City of Bartlesville, Washington County, Oklahoma (the "Restrictions"), and

WHEREAS, the Restrictions provide that the same may be amended by instrument signed by a majority of the then owners of lots agreeing to such modification or amendment.

WHEREAS, pursuant to notice and meeting, a sufficient percentage of record owners of parcels within the Addition voted to amend the Covenants and to approve the Amendment, the ballots of such owners voting to approve being attached hereto.

NOW THEREFORE, the Restrictions are hereby amended by striking paragraphs 3, 4, 10, and 11 (as previously amended) and in their place, substituting the following:

3. No residence shall be constructed containing less than 3,000 square feet of finished heated living area with a minimum of 2,400 square feet of finished heated living area on the first floor. The first story exterior walls of each residence shall be constructed of 100% masonry brick, brick veneer, stone or stone veneer; provided however, that the area of all windows and doors located in said exterior walls and the area adjacent to patios and under porches shall be excluded in the determination of the area of exterior walls, and further provided that where a part of the exterior wall is extended above the interior room ceiling line due to the construction of a gable type roof, then that portion of the wall extending above the interior room ceiling height may be constructed of other material (subject to the approval of the Prairie Ridge Property Owner's Association Board or its designee) and shall be excluded from the determination of the area of the exterior walls. A minimum of 9/12 pitch for roof systems on single story and two story dwellings shall be used, except over porches and patios where a minimum of 4/12 will be permitted.

Fencing: No fence, whether ornamental or otherwise, shall be erected on any lot nearer to the front property line than the front building setback line and with regard to any and all corner lots, no fence shall be erected nearer to the side property line than the side building set back line. In no event shall any chain link or wire fence be permitted on any lot.
